




Worldwide Regulated Open-ended Fund Assets and Flows

Trends in the First Quarter of 2022





Worldwide regulated open-end fund assets decreased by 2.5% in euro terms to EUR 65.7 trillion in Q1 2022.¹ Worldwide net inflows to all funds amounted to EUR 94 billion, compared to EUR 1,023 billion in Q4 2021.



¹ The information presented in this report was compiled by EFAMA and the Investment Company Institute (ICI) on behalf of the International Investment Funds Association (IIFA), the organization of national investment fund associations. Statistics from 46 countries are included in this report. All data presented in this report include funds of funds, exchange-traded funds and institutional funds.

Worldwide investment fund net assets measured in U.S. dollars decreased to USD 72.9 trillion at the end of Q1 2022; this represented a decline of 4.4%. The following two graphs compare the net asset growth in the seven largest countries/regions.

On a euro-denominated basis, worldwide equity fund assets decreased by 4% to EUR 29.1 trillion at the end of Q1 2022. Bond fund assets fell by 2.2% to EUR 12.2 trillion. Multi-asset funds declined by 2.7% to EUR 11.1 trillion. Money market funds decreased by 0.3% to EUR 7.8 trillion.





At the end of Q1 2022, 44.2% of worldwide regulated open-end fund net assets were held in equity funds. The share of bond funds amounted to 18.6% and the asset share of multi-asset funds was 16.8%. Money market fund assets represented 11.8% of the worldwide total.


**Exhibit 6: Worldwide Regulated Open-End Funds Net Assets
(by Type of Fund, 2022:Q1)**




Looking at the worldwide distribution of investment fund net assets at the end of Q1 2022, the United States and Europe held the largest shares in the world market, with 48.5% and 30.7%, respectively. China (4.8%), Australia (3.7%), Canada (3.4%), Japan (3.1%), Brazil (3.1%), Republic of Korea (1%), India (0.7%) and South Africa (0.3%) follow in this ranking.



Overall, five European countries ranked among the top ten largest fund domiciles in the world: Luxembourg (with 8.5% of worldwide investment fund assets), Ireland (6%), Germany (4.1%), France (3.3%), and the United Kingdom (3.1%).



Net sales of worldwide regulated open-end funds decreased to EUR 94 billion in Q1 2022, down from EUR 1,023 billion in Q4 2021. Long-term funds recorded net inflows of EUR 282 billion, compared to EUR 753 billion in Q4 2021. Money market funds registered net outflows of EUR 188 billion, compared to net inflows of EUR 270 billion in Q4 2021.



Globally, equity funds recorded net inflows of EUR 185 billion, compared to EUR 271 billion in Q4 2021. Bond funds registered net outflows of EUR 50 billion, compared to net inflows of EUR 206 billion in Q4 2021. Multi-asset funds decreased from EUR 168 billion in Q4 2021 to EUR 90 billion in Q1 2022.



Net sales of regulated open-end funds amounted to EUR 172 billion in the Asia-Pacific region², mainly driven by net inflows in China (EUR 111 billion) and to a lesser extent the Republic of Korea (EUR 26 billion) and Japan (EUR 25 billion). The Americas³ recorded net inflows of EUR 45 billion (of which EUR 36 billion in Canada and EUR 7 billion in Brazil).

Europe recorded net outflows of EUR 69 billion. Over the quarter, the largest net inflows were registered in Switzerland (EUR 36 billion) and Germany (EUR 36 billion). Net outflows were concentrated in France (EUR 55 billion), Luxembourg (EUR 47 billion) and the Netherlands (EUR 36 billion).

The United States recorded net outflows of EUR 54 billion in Q1 2022, compared to net inflows of EUR 442 billion in Q4 2021. Money market funds and bond funds registered net outflows of EUR 144 billion and EUR 39 billion, respectively.




In Europe, long-term funds recorded net inflows of EUR 55 billion, down from EUR 169 billion in Q4 2021. Equity funds recorded net sales of EUR 5 billion, down from EUR 41 billion in Q4 2021. Bond funds registered net outflows of EUR 38 billion, compared to net outflows of EUR 15 billion in Q4 2021. Net sales of multi-asset funds amounted to EUR 77 billion, up from EUR 71 billion in Q4 2021. Money market funds registered net outflows of EUR 124 billion, compared to net inflows of EUR 92 billion in Q4 2021.

In the United States, net inflows of long-term open-end funds amounted to EUR 91 billion, down from EUR 256 billion in Q4 2021. Equity funds recorded net inflows of EUR 117 billion, compared to EUR 147 billion in Q4 2021. Bond funds registered net outflows of EUR 39 billion in Q1 2022, compared to net inflows of EUR 92 billion in Q4 2021. Multi-asset funds registered net outflows of EUR 4 billion, compared

to net inflows of EUR 18 billion in Q4 2021. Money market funds recorded net outflows of EUR 144 billion, compared to net inflows of EUR 187 billion in Q4 2021.
